Corporate Profile 公司簡介

Sino Harbour Property Group Limited ("Sino Harbour" or the "Company") and its subsidiaries (together, the "Group") is a property developer focused on residential properties in Jiangxi Province, the People's Republic of China (the "PRC"). The residential projects developing by the Group are coupled with retail shops and other commercial office premises.

The Group's first project was Nanchang Honggu Kaixuan (南昌紅谷凱旋), a residential and commercial development in Honggu Tan Central District of Nanchang City, Jiangxi Province, the PRC. Nanchang Honggu Kaixuan occupies a total site area of approximately 80,521 square metres ("**sq. m.**"), comprising residential and commercial development with an aggregate saleable gross floor area ("**GFA**") of approximately 304,839 sq. m.

In 2009, the Group further explored and capitalised opportunities in Fuzhou (撫州) , Jiangxi Province, the PRC to develop the second project Fuzhou Hua Cui Ting Yuan (撫州 華 萃 庭 院) . Fuzhou Hua Cui Ting Yuan occupies a total site area of approximately 190,753 sq. m. with a planned aggregate saleable GFA of approximately 297,955 sq. m.

During the financial year ended 31 March 2012, the Group's joint venture Jiangxi Ganghong Investment Co., Ltd. (江西港洪實業有限公司) started the pre-sale of Yichun Royal Lake City (宜春御湖城) in Yichun, Jiangxi Province, the PRC. Yichun Royal Lake City occupies a total site area of approximately 607,084 sq. m. with a planned aggregate saleable GFA of approximately 1,244,115 sq. m.

During the financial year ended 31 March 2013, the Group commenced the development of Nanchang Sino Harbour Island Villa (南昌漢港林島), formerly known as Nanchang Dingxun project (南昌鼎迅項目), in Nanchang. Nanchang Sino Harbour Island Villa occupies a total site area of approximately 719,547.5 sq. m. with a planned aggregate saleable GFA of approximately 1,004,788 sq. m.

Going forward, the Group will make an effort to replicate its successful investment model in property projects with strong potential elsewhere in the PRC in order to generate better growth.

漢港房地產集團有限公司(「**漢港**」或「本公司」) 及其附屬公司(統稱「本集團」)為一家專注於開發中華人民共和國(「中國」)江西省住宅物業的物業開發商。本集團致力開發住宅項目連同零售店舖與其他商業辦公物業。

本集團的首個項目為南昌紅谷凱旋,有關項目乃位於中國江西省南昌市紅谷灘中心區的住宅及商業開發項目。南昌紅谷凱旋的總地盤面積約為80,521平方米(「平方米」),包括可售總建築面積(「建築面積」)合共約304,839平方米的商住開發項目。

於二零零九年,本集團進一步物色及利用中國江西省撫州的商機以開發第二個項目撫州華萃庭院。撫州華萃庭院的總地盤面積約為190,753平方米,規劃可售建築面積合共約為297,955平方米。


截至二零一二年三月三十一日止財年,本集團的合營企業江西港洪實業有限公司開始預售位於中國江西省宜春之宜春御湖城。宜春御湖城的總地盤面積約為607,084平方米,規劃可售建築面積合共約為1,244,115平方米。

截至二零一三年三月三十一日止財年,本集團開始開發南昌的南昌漢港林島(前稱為南昌鼎迅項目)。南昌漢港林島的總地盤面積約為719,547.5平方米,規劃可售建築面積合共約為1,004,788平方米。

展望未來,本集團將致力於中國其他地區複製其具強大潛力的物業項目的成功投資模式,以錄得更佳增長。

Dear Shareholders,

I am pleased to present to the shareholders of the Company (the "Shareholders") the results in the financial performance of the Company and its subsidiaries for the year ended 31 March 2013.

In the year ended 31 March 2013, revenue was mainly derived from the sales of residential properties of Fuzhou Hua Cui Ting Yuan (撫州華萃庭院) and Yichun Royal Lake City (宜春御湖城) and the sales of commercial units of Nanchang Honggu Kaixuan (南昌紅谷凱旋). Revenue from commercial and residential properties increased steadily in the year ended 31 March 2013 compared with the previous financial year. During the year under review, profit attributable to owners of the Company amounted to RMB126.4 million, representing an increase of 24.8% over that of last year.

In March 2013, the Group succeeded in acquiring a parcel of land for commercial development in Hangzhou, Zhejiang Province. The land would be developed into a commercial complex with office premises and retail shops. The board (the "Board") of directors (the "Directors") believes the investment value of the land will continue to rise as it is located in a prime location in Hangzhou.

本人欣然向本公司股東(「**股東**」)提呈本公司及 其附屬公司截至二零一三年三月三十一日止年度 之財務表現業績。

截至二零一三年三月三十一日止年度,收入主要來自銷售住宅物業撫州華萃庭院及宜春御湖城以及銷售商業單位南昌紅谷凱旋。截至二零一三年三月三十一日止年度,來自商業及住宅物業之收入較上一財年穩定地增加。於回顧年度,本公司擁有人應佔溢利達人民幣126.4百萬元,較去年增加24.8%。

於二零一三年三月,本集團成功收購一幅位於浙 江省杭州市之土地,以作商業開發用途。該土地 將被開發為商業中心,設有寫字樓和零售店舖。 董事(「董事」)會(「董事會」)相信,該土地因位 於杭州市之黃金地段,其投資價值將繼續攀升。

Looking ahead, the property market in the PRC will continue to be affected by the PRC government's restrictive measures. The restrictive measures will continue to have greater impact on the residential market as compared with the commercial market as a whole.

展望未來,中國物業市場仍將受中國政府限制措 施所影響。相較於商業物業市場而言,限制措施 整體上將繼續對住宅物業市場造成更大影響。

The Group will continue its focus in the third- and fourth-tier cities by exploring new opportunities and diversify our property portfolio so as to alleviate the impact to the Group by the restrictive measures. All in all, the Group is confident with the PRC's property market due to urbanisation and sustainable economic growth of the PRC.

REVENUE

During the year under review, the Group achieved revenue of approximately RMB559.9 million mainly from the sales of residential units of Fuzhou Hua Cui Ting Yuan (撫州華萃庭院) and Yichun Royal Lake City (宜春御湖城), together with the commercial units of Nanchang Honggu Kaixuan (南昌紅谷凱旋). Revenue increased by approximately 8.7% over the previous financial year. The total GFA of the residential and commercial units (excluding car parking spaces) sold in the year under review amounted to approximately 99,983 sq. m.

The following table sets out an analysis of the revenue for (i) residential properties, (ii) commercial properties, and (iii) car parking spaces during the year under review:

收入

於回顧年度,本集團錄得收入約為人民幣559.9百萬元,主要來自銷售撫州華萃庭院及宜春御湖城之住宅單位,連同南昌紅谷凱旋之商業單位。收入較上一財年增長約8.7%。於回顧年度已售住宅及商業單位(不包括停車位)總建築面積約為99,983平方米。

COST OF SALES AND GROSS PROFIT MARGIN

Cost of sales increased from approximately RMB300.2 million in the previous financial year to approximately RMB369.3 million for the year under review. In the previous financial year, a greater portion of revenue was derived from the delivery of commercial units and car parking spaces which have a higher gross profit margin compared with the greater proportion of residential units sold during the year under review. Consequently, gross profit margin decreased from 41.7% for the previous financial year to 34.1% for the year under review.

OTHER INCOME

Other income increased from approximately RMB15.8 million (restated) in the previous financial year to approximately RMB41.0 million in the year under review. The increase mainly represented the increase in net fair value gain of the Group's investment properties and properties held under development upon transfer to investment properties during the year under review.

SELLING AND DISTRIBUTION EXPENSES

Selling and distribution expenses increased from approximately RMB3.9 million (restated) in the previous financial year to approximately RMB13.3 million in the year under review. The higher selling expenses in the year under review was mainly due to the increase in marketing expenses for Yichun Royal Lake City (宜春御湖城).

銷售成本及毛利率

銷售成本由上一財年約人民幣300.2百萬元增長至回顧年度約人民幣369.3百萬元。於上一財年,收入有較大部分來自商業單位及停車位之交付,其毛利率較於回顧年度佔較大比例之已出售住宅單位之毛利率為高。因此,毛利率由上一財年之41.7%減少至回顧年度之34.1%。

其他收入

其他收入由上一財年約人民幣15.8百萬元 (經重列)增長至回顧年度約人民幣41.0百萬元。該增長主要為回顧年度內本集團投資物業及自開發中物業轉撥至投資物業之公平值收益淨額增加。

銷售及分銷費用

銷售及分銷費用由上一財年約人民幣3.9百萬元 (經重列)增加至回顧年度約人民幣13.3百萬元。 回顧年度銷售費用較高主要由於宜春御湖城市場 營銷費用增加所致。

ADMINISTRATIVE EXPENSES

Administrative expenses increased to approximately RMB20.2 million in the year under review from approximately RMB15.0 million (restated) in the previous financial year. The increase was mainly attributable to the increase in staff costs, professional & consultancy expenses and land use tax of approximately RMB1.2 million, RMB1.0 million and RMB2.8 million respectively.

PROFIT FOR THE YEAR

As a cumulative effect of the foregoing factors, the Group had recorded a profit before tax of approximately RMB198.2 million in the year under review, representing a decrease of 1.3% from approximately RMB200.7 million in the previous financial year.

Income tax expense decreased from approximately RMB99.9 million in the previous financial year to approximately RMB73.0 million in the year under review. The decrease in income tax was mainly derived from the decrease in Land Appreciation Tax ("LAT") resulting from the lower assessable value of properties delivered to the customers during the year under review. According to the Provisional Regulations of the PRC on LAT and relevant implementation rules, an entity deriving a profit from selling or transferring properties shall be liable to pay LAT at progressive rates from 30% to 60% of the appreciated value of the property, with certain exemptions available for the sale of ordinary residential properties if the appreciated value does not exceed 20% of the deductible items as defined in the relevant LAT regulations. Sales of commercial properties are not eligible for such exemption.

As a result, profit for the year attributed to the owners of the Company increased by approximately 24.8% from approximately RMB101.3 million in the previous financial year to approximately RMB126.4 million in the year under review.

INTEREST IN A JOINT VENTURE

Interest in a joint venture increased from approximately RMB95.1 million (restated) as at 31 March 2012 to RMB174.1 million as at 31 March 2013. The increase represented the advance to the joint venture by the Group for Yichun Royal Lake City(宜春御湖城)Phase 3.

管理費用

管理費用由上一財年約人民幣15.0百萬元(經重列)增加至回顧年度約人民幣20.2百萬元,主要由於員工成本、專業及顧問費及土地使用稅分別增長約人民幣1.2百萬元、人民幣1.0百萬元及人民幣2.8百萬元所致。

年內溢利

由於以上因素之綜合影響,本集團於回顧年度錄得除稅前溢利約人民幣198.2百萬元,較上一財年約人民幣200.7百萬元減少1.3%。

所得税開支自上一財年約人民幣99.9百萬元減少至回顧年度約人民幣73.0百萬元。所得稅減少乃主要由於回顧年度內向客戶交付之物業應課稅價值減少導致土地增值稅(「土地增值稅」)減少所致。根據中國土地增值稅暫行條例及相關實施知則,實體因出售或轉讓物業而產生之收益須按物業增值額以由30%至60%之累進稅率繳納土地增值稅,銷售一般住宅物業可獲若干豁免,惟增值額不可超過可扣減項目(定義見相關土地增值稅法規)金額之20%。銷售商業物業不合資格獲得有關豁免。

因此,本公司擁有人應佔年內溢利由上一財年約人民幣101.3百萬元增長至回顧年度約人民幣126.4百萬元,增長約24.8%。

於一間合營企業之權益

於一間合營企業之權益自於二零一二年三月 三十一日約人民幣95.1百萬元(經重列)增長至於 二零一三年三月三十一日人民幣174.1百萬元。該 增長乃由於本集團為宜春御湖城第三期向合營企 業作出墊款所致。

PROPERTIES HELD UNDER DEVELOPMENT

As at 31 March 2013, the Group's properties held under development decreased to approximately RMB1,066.0 million from approximately RMB1,078.3 million (restated) as at 31 March 2012. The decrease was because certain property units which were previously under development had been completed in the year under review.

PROPERTIES HELD FOR SALE

Properties held for sale decreased from approximately RMB338.5 million as at 31 March 2012 to approximately RMB311.2 million as at 31 March 2013. The decrease was mainly due to the delivery of the completed residential property units of Yichun Royal Lake City (宜春御湖城) Phase 1 to buyers in the year under review.

PREPAYMENTS AND OTHER RECEIVABLES

As at 31 March 2013, the Group's prepayments and other receivables amounted approximately RMB152.8 million, compared to approximately RMB87.4 million (restated) as at 31 March 2012. The increase was mainly attributable to the increase of prepayments to contractors for the construction of projects.

ACCOUNTS PAYABLE, ACCRUALS, RECEIPTS IN ADVANCE AND OTHER PAYABLES

Accounts payable increased to approximately RMB29.3 million as at 31 March 2013 from approximately RMB17.8 million (restated) as at 31 March 2012 due to the increase in the number of the Group's property projects completed near 31 March 2013. Accounts payable mainly comprised amount payable to suppliers for construction costs incurred in respect of the Group's properties under development.

Accruals, receipts in advance and other payables mainly comprise of the advance receipts from customers in respect of deposit and prepayments for the Group's property pre-sales, and the accrued construction costs and project-related expenses that are based on the progress of project development but are not due for payment.

開發中物業

於二零一三年三月三十一日,本集團開發中物業由於二零一二年三月三十一日約人民幣1,078.3百萬元(經重列)減少至約人民幣1,066.0百萬元。該減少乃由於若干先前尚在開發當中之物業單位已於回顧年度內竣工所致。

待售物業

於二零一三年三月三十一日,待售物業由於二零 一二年三月三十一日約人民幣338.5百萬元減少 至約人民幣311.2百萬元,該減少主要由於宜春御 湖城第一期之竣工住宅單位已於回顧年度內交付 予買家所致。

預付款項及其他應收款項

於二零一三年三月三十一日,本集團預付款項及 其他應收款項金額約為人民幣152.8百萬元,而於 二零一二年三月三十一日則約為人民幣87.4百萬 元(經重列)。該增長乃主要由於就建築項目向承 建商支付之預付款項增加所致。

應付賬款、應計款項、預收款項及其他應付款項

於二零一三年三月三十一日,由於接近二零一三年三月三十一日竣工之本集團物業項目增加,應付賬款自於二零一二年三月三十一日約人民幣17.8百萬元(經重列)增長至約人民幣29.3百萬元。應付賬款主要包括就本集團開發中物業產生之建築成本應向供應商支付之款項。

應計款項、預收款項及其他應付款項主要包括來 自客戶就本集團物業預售所支付之按金及預付款 項、以及根據項目開發進度所預提之建築成本及 項目相關費用(惟尚未到期支付)。

ACCOUNTS PAYABLE, ACCRUALS, RECEIPTS IN ADVANCE AND OTHER PAYABLES (continued)

Accruals, receipts in advance and other payables decreased to approximately RMB430.6 million as at 31 March 2013 from approximately RMB478.8 million (restated) as at 31 March 2012. The decrease mainly represented the advance receipts realised as revenue in the year under review, which was partially offset by the receipts from customers for the deposits and prepayments for the Group's property pre-sales in the same period.

LIQUIDITY AND FINANCIAL RESOURCES

In the year ended 31 March 2013, the Group had recorded a net cash inflow of approximately RMB54.2 million from operating activities, mainly as a result of the profit before working capital change and being partially offset by payment of Enterprise Income Tax and LAT.

Net cash outflow from investing activities for the year under review was approximately RMB316.5 million, which was mainly due to the increase in pledged deposits of approximately RMB237.3 million and the advance of approximately RMB79.0 million to the joint venture by the Group for Yichun Royal Lake City (宜春御湖城) Phase 3.

Net cash generated from financing activities for the year under review was approximately RMB410.7 million mainly representing the receipts from new bank and other loans.

As at 31 March 2013, the Group had cash and bank balances of approximately RMB240.9 million (31 March 2012: approximately RMB92.8 million (restated)).

The Group expects that income generated from business operations and borrowings will continue to be major sources of funding in the coming financial year. As a result, the Group will continue to strengthen cash flow management, improve the efficiency of capital returns of projects and strictly control the cost and various expenses.

應付賬款、應計款項、預收款項及其他應付款項(續)

於二零一三年三月三十一日,應計款項、預收款項及其他應付款項較於二零一二年三月三十一日約人民幣478.8百萬元(經重列)減少至約人民幣430.6百萬元,主要由於預收款項在回顧年度已實現為收入,同時被同期客戶就本集團物業預售所支付之按金及預付款項部分抵銷所致。

資金流動性及財務資源

FUTURE OUTLOOK

Having established its pioneering position in the Jiangxi Province property market, the Group aims at accelerating its growth by developing residential and commercial projects in the PRC that generate high returns. Consistent with this aim, the Group will replicate its successful investment model in property projects to expand its presence elsewhere in the country. On the other hand, the Group is actively expanding into emerging overseas markets to benefit from an early-mover advantage. In particular, South Africa will be closely examined, given the country's reasonable development costs and promising market growth. The Group will also expedite efforts at identifying property projects with high investment potential by leveraging its extensive network.

In March 2013, the Group succeeded in securing a parcel of land in Hangzhou, Zhejiang Province, the PRC. With a planned construction floor area of approximately 81,928 sq. m., the project is to be developed for commercial use. This initiative demonstrated the Group's determination in diversifying its property portfolio to capture the increasing demand for commercial premises as well as retail outlets. By adding quality investment projects to its existing property portfolio, the Group aims to enhance the overall value of its assets and strengthen its business and financial base, leading to long-term and satisfactory returns for its Shareholders.

Looking to the PRC property market, tighter control on the market has been applied repeatedly by the PRC government since the end of 2012. In the State Council Executive Meeting dated 20 February 2013, the PRC government expressed its determination to implement "The Five New Measures" to strengthen control over the property market by repeatedly stating its desire to eliminate house purchases for speculation and investment, refining the home purchase quota policy and implementing differential housing credit policies. At the same time, it is expressly stated a general policy direction of non-relaxation of property market restrictions.

Overall, the Group expects the PRC property market will remain challenging in 2013. The Group is of the view that a series of PRC government policy measures including "price restrictions", "purchase restrictions" and "credit limits" to curb the excessive growth of housing prices will continue. Nonetheless, it is worthy to emphasise that the PRC government aims at setting up an effectively comprehensive regulatory regime to realise the long-term healthy and stable development of the property market. The government in this way aims to allow the growth of housing demand for self-use, rather than speculative or investment demand, to be satisfied. Furthermore, urbanisation in the PRC will generate constant demand for housing, and sustainable economic growth will stimulate demand for improved housing, suggesting that the PRC's property market will undergo a long-term growth cycle.

Currently, the Board comprises six Directors, including two executive Directors, Mr. Shi Feng and Mr. Wong Lui, a non-executive Director Ms. Chan Heung Ling and three independent non-executive Directors, Mr. Xie Gang, Mr. Lee Man To and Ms. Zhang Juan. Mr. Wong Lui is the son of Ms. Chan Heung Ling. Save as disclosed above, there is no family or other material relationship among members of the Board. One third of the Directors are subject to retirement from office by rotation and re-election at each annual general meeting provided that every Director shall be subject to rotation at least once every three years in accordance with the Bye-Laws of the Company.

All Directors, including independent non-executive Directors, have given sufficient time and effort to the affairs of the Group. Independent non-executive Directors have provided the Board with their diversified expertise, experience and professional advice. The Board believes that the ratio between executive Directors and independent non-executive Directors is reasonable and adequate to provide sufficient checks and balances that safeguard the interests of Shareholders and the Group. The Board also believes that the views and participation of the independent non-executive Directors in the Board and committee meetings provides independent judgment on the issues relating to strategy, performance, conflict of interest and management process to ensure that the interests of all Shareholders are considered and safeguarded.

(A) 董事會(續)

各執行董事及非執行董事均與本公司訂立 特定任期為三年的服務合同。根據本公司 之章程細則,董事會獲授權委任任何人士 為董事,以填補董事會空缺或作為新增董 事。倘存在空缺,董事會將會參考建議候選 人之技能、經驗、資格、誠信及時間投入進 行甄選程序。

本公司已根據上市規則第3.10條委任三名獨立非執行董事,其中一人擁有合適的會計及財務管理專業資格。各獨立非執行董事已確認其獨立於本公司,而本公司的提上市規則第3.13條所載評估獨立性的指引認為彼等為獨立。各獨立非執行董事已與本公司訂立特定任期為一年的聘任函件。三份之一的董事須按本公司之至經知則每年在股東週年大會上輪值退任人次。

所有董事(包括獨立非執行董事)已投放充足時間及精力於本集團的事務上。獨立非執行董事已向董事會給予他們在多方面的專業知識、經驗及專業意見。董事會相信執行董事與獨立非執行董事的比例為合理,足以提供充分的制衡,以保障股東及首連,以提供充分的制衡,以保障股東有關策略、表現、利益衝突及管理過程的利益有關策略、表現、利益衝突及管理過程的利益得到考慮及保障。

(A) THE BOARD OF DIRECTORS (continued)

All Directors have full and timely access to all relevant information in relation to the Group's businesses and affairs as well as unrestricted access to the advice and services of the company secretary, who is responsible for providing Directors with Board papers, and related materials. The Directors may seek independent professional advice at the Company's expenses in carrying out their duties and responsibilities.

The Company has subscribed appropriate and sufficient insurance coverage on Directors' liabilities in respect of legal actions taken against Directors arising out of corporate activities.

The Directors are committed to complying with the code provision A.6.5 of the Code Provisions. All Directors have participated in continuous professional development and provided a record of training they received for the year ended 31 March 2013 to the Company.

The individual training record of each Director received for the year ended 31 March 2013 is set out below:

(A) THE BOARD OF DIRECTORS (continued)

During the year ended 31 March 2013, the Board held seven meetings. At these board meetings, Directors discussed and exchanged their views on significant issues and general operations of the Group, reviewed the financial performance and reviewed and approved the quarterly, interim and final results.

At least 14 days notice prior to the date of meeting is given to all Directors and an agenda together with board papers are sent to all Directors no less than three days before the date of meeting. All Directors are given opportunity to include in the agenda any other matter that they would like to discuss in the meeting. Regarding the board committee meeting, reasonable prior notice is given to all committee members.

The company secretary assists the Chairman of the Board in preparation of the agenda for the board meeting and board committee meeting. He also prepares and keeps detailed minutes of each board meeting and board committee meeting. Within a reasonable time after each meeting, the draft minutes are circulated to all Directors or committee members for comment and the final and approved version of minutes is sent to all Directors and committee members for their record. The company secretary has duly complied with the relevant professional training requirement under Rule 3.29 of the Listing Rules.

(B) CHAIRLADY AND CHIEF EXECUTIVE OFFICER

Ms. Chan Heung Ling is the Chairlady of the Board and Mr. Shi Feng is the Chief Executive Officer of the Company. The division of responsibilities between the Chairlady and the Chief Executive Officer are clearly divided to ensure a balance of power and authority.

Ms. Chan Heung Ling, being the Chairlady, is responsible for formulating the Company's overall strategies and policies, providing leadership to the Board and ensuring the Board functions effectively. She would ensure complete, reliable and timely information being provided to the Directors and encourage Directors to actively participate in the Board to act in the best interest of the Company.

(A) 董事會(續)

截至二零一三年三月三十一日止年度,董事會舉行七次會議。於該等董事會會議上,董事就本集團的重要議題及一般營運進行討論及交換意見,檢討財務表現,以及審閱及批准季度、中期及末期業績。

(B) CHAIRLADY AND CHIEF EXECUTIVE OFFICER (continued)

Mr. Shi Feng, being the Chief Executive Officer, is responsible for the daily operations of the Company, execution of business policies, strategies, objectives and plans as formulated and adopted by the Board and leading the management of the Company.

(C) COMPLIANCE WITH MODEL CODE

The Company has adopted the Model Code for Securities Transactions by Directors of the Listed Issuers (the "Model Code") set out in Appendix 10 to the Listing Rules as its code of conduct for securities transactions by the Directors. After having made specific enquiries with all Directors, all Directors confirmed that they have complied with the required standards set out in the Model Code throughout the year ended 31 March 2013.

(D) DIRECTORS' RESPONSIBILITY FOR THE FINANCIAL STATEMENTS

The Directors acknowledge their responsibility for preparation of the consolidated financial statements for the financial year ended 31 March 2013, which give a true and fair view of the state of affairs of the Company and the Group at 31 March 2013 and of the Group's results and cash flows for the year then ended and are properly prepared on going concern basis in accordance with the applicable statutory requirements and accounting standards.

The external auditor of the Group have also stated their reporting responsibility in the auditor's report of the consolidated financial statements.

(E) BOARD COMMITTEES

The Board has established three board committees, namely audit committee, remuneration committee and nomination committee, to oversee particular aspects of the Company's affairs. The Board committees are provided with sufficient resources to discharge their duties.

(B) 主席及首席執行官(續)

(C) 遵守標準守則

(D) 董事對財務報表的責任

董事知悉彼等編製截至二零一三年三月三十一日止財年的綜合財務報表的責任, 財務報表如實公平反映本公司及本集團於 二零一三年三月三十一日的事務狀況及本 集團截至該日期止年度的業績及現金流, 並根據適用的法定規定及會計準則按持續 經營基準妥為編製。

本集團之外聘核數師亦已於綜合財務報表 之核數師報告內作出彼等之申報責任聲 明。

(E) 董事委員會

董事會已成立三個董事委員會,分別為審核委員會、薪酬委員會及提名委員會,以監察本公司特定範疇的事務。董事委員會得到充足資源履行其責任。

(E) BOARD COMMITTEES (continued)

The written terms of reference for each committee were adopted by the Board. The terms of reference are in line with the Listing Rules and they are posted on the websites of the Stock Exchange and the Company.

(F) AUDIT COMMITTEE AND ACCOUNTABILITY

In compliance with Rule 3.21 of the Listing Rules, an audit committee was established on 4 July 2011 with written terms of reference in accordance with the Corporate Governance Code as set out in Appendix 14 to the Listing Rules. The audit committee comprises three independent non-executive Directors, namely Mr. Lee Man To (the chairman), Mr. Xie Gang and Ms. Zhang Juan. The audit committee reports to the Board and is delegated by the Board to assess matters related to the financial statements. Under its terms of reference, the audit committee is required to perform, amongst others, the following duties:

- monitoring whether the Group's management has, in the performance of its duties, infringed any policies set by the Board or any applicable laws, regulation and code and report to the Board;
- reviewing the Group's internal control procedures and system;
- making recommendations to the Board for the improvement of the Group's internal control procedures and system;
- making recommendations to the Board on the appointment, reappointment and removal of the external auditor, and to approve and review the remuneration and terms of engagement of the external auditor and any questions of its resignation or dismissal; and
- monitoring the integrity of accounts, financial statements, interim reports and annual reports.

(E) 董事委員會(續)

董事會已採納各委員會之書面職權範圍。 該等職權範圍符合上市規則,並刊載於聯 交所及本公司網站。

(F) 審核委員會及問責性

本公司已根據上市規則第3.21條於二零一一年七月四日成立審核委員會,及根據上市規則附錄十四的企業管治守則界定其書面職權範圍。審核委員會由三名獨立非執行董事組成,即李敏滔先生(主席)、解剛先生及張娟女士。審核委員會向董事會匯報及獲董事會授權評估與財務報表有關的事宜。根據職權範圍,審核委員會須履行(其中包括)以下職責:

- 監督本集團的管理人員在履行其職 責時是否干犯董事會制定的任何政 策或任何適用法律、法規及守則並 向董事會報告:
- 檢討本集團的內部監控程序與系統;
- 就本集團的內部監控程序與系統向 董事會提出改善建議;
- 就委任、重新委任及罷免外聘核數師、批准及檢討外聘核數師的薪酬及委聘條款以及其辭任或解除委任的任何問題向董事會提出建議;及
- 監察賬目、財務報表、中報及年報的 完整性。

(F) AUDIT COMMITTEE AND ACCOUNTABILITY (continued)

The audit committee held four meetings during the year and all minutes were kept by the company secretary. The committee has reviewed the accounting policies and practices adopted by the Group and the quarterly and interim results of the Group. The committee reported that there was no material uncertainty that cast doubt on the Company's going concern ability.

Auditors' remuneration

The total fees paid/payable in relation to the audit service provided by BDO Limited, Certified Public Accountants, Hong Kong, the external auditors of the Company, for the year ended 31 March 2013 amounted to HK\$830,000. No non-audit service was provided by the external auditors for the year ended 31 March 2013.

(G) REMUNERATION COMMITTEE

The remuneration committee was established with written terms of reference in accordance with the Code Provision as set out in Appendix 14 to the Listing Rules. The main responsibilities of the remuneration committee include but not limited to formulate remuneration policy for the approval of the Board, and make recommendations to the Board on the Company's policy and structure for the remuneration of all Directors and senior management. The remuneration committee comprises three independent non-executive Directors, namely Mr. Xie Gang (the chairman), Mr. Lee Man To and Ms. Zhang Juan, non-executive Director Ms. Chan Heung Ling and one executive Director Mr. Shi Feng.

Two remuneration committee meetings were held during the year to review the remuneration policies and determine the annual bonus of the Directors and senior executives.

(F) 審核委員會及問責性(續)

The major duties of the nomination committee are to give advice to the Board on the appointment/re-appointment of Directors, to review the structure, number of members and composition of the Board, and to assess the independence of independent non-executive Directors.

The nomination committee comprises three independent non-executive Directors, namely Mr. Xie Gang (the chairman), Mr. Lee Man To and Ms. Zhang Juan, and one executive Director Mr. Wong Lui.

One meeting was held during the year, all committee members had attended the meeting.

(J) INTERNAL CONTROL

The Board acknowledges its responsibility for maintaining a sound system of internal control framework. The controls are to provide reasonable assurance to safeguard Shareholders investments and the Group's assets. The system of internal controls is designed to manage rather than eliminate the risk of failure to achieve business objectives. It can only provide reasonable but not absolute assurance against material misstatement or loss and the review of the Group's internal control systems should be a concerted and continuing process.

The Group's control environment provides the foundation upon which all other components of internal controls are built upon. It provides discipline and structure, setting the tone of the organisation and influencing the control consciousness of its staff. A weak control environment foundation hampers the effectiveness of even the best designed internal control procedure.

The external auditor have, during the course of audit, considered the internal control relevant to the Group's preparation of the consolidated financial statements within the scope of their audit. The Board, through the audit committee, had reviewed the effectiveness of the internal control system of the Group, and also reviewed adequacy of resources, qualifications and experience of staff of the Company's accounting and financial reporting function, and their training programmes and budget. The Board believes that the existing internal control system is adequate and effective.

(K) SHAREHOLDER RELATIONS

The Group is committed to regular and proactive communication with its Shareholders. The Company has adopted a policy of disclosing clear, adequate and relevant information to Shareholders in a timely manner through various channels. Annual and interim reports are printed and sent to all Shareholders by post as requested. The Company has complied with provisions of the Listing Rules by posting announcements, notices, quarterly reports, interim reports, annual reports and Shareholders' circulars on the website of the Stock Exchange and the Company (http://www.sinoharbour.com.hk).

(J) 內部監控

Notice of annual general meeting is delivered to all Shareholders at least 20 clear business days prior to the date of the meeting, setting out details of each proposed resolution, voting procedures (including procedures for demanding and conducting a poll) and other relevant information. As at the beginning of the meeting, the procedures for demanding and conducting a poll will be explained by the Chairman of the Board. Vote results are released by way of publication of an announcement.

(L) SHAREHOLDERS' RIGHTS

How Shareholders can convene a Special General Meeting

According to Bye-law 58 of the Company's Bye-laws, Shareholders holding, at the date of deposit of the requisition, not less than one-tenth of the paid up capital of the Company carrying the right of voting at general meetings of the Company shall have the right to require a special general meeting to be called by the Board for the transaction of any business specified in such requisition.

The requisition shall be in writing addressed to the Board or the company secretary and deposited at the Company's principal place of business in Hong Kong at Room 1215, Tower B, Hunghom Commercial Centre, 37 – 39 Ma Tau Wai Road, Hunghom, Kowloon, Hong Kong.

If within twenty-one (21) days of such deposit the Board fails to proceed to convene such meeting, the requisitionists themselves may do so in accordance with section 74(3) of the Companies Act of Bermuda.

1. GENERAL INFORMATION

Sino Harbour Property Group Limited (the "Company") was incorporated in Bermuda on 5 January 2011 as an exempted company with limited liability under the Companies Act 1981 of Bermuda. The registered office of the Company is located at Clarendon House, 2 Church Street, Hamilton HM 11, Bermuda and the principal place of business of the Company is located at Room 1215, Tower B, Hunghom Commercial Centre, 37-39 Ma Tau Wai Road, Hunghom, Kowloon, Hong Kong.

The principal activity of the Company is investment holding. The principal activities of the Company's subsidiaries are set out in note 16 to the consolidated financial statements. The directors of the Company considered Pan Hong Property Group Limited ("Pan Hong Property"), a company listed on Singapore Exchange Limited, as the ultimate holding company.

The consolidated financial statements on pages 52 to 146 have been prepared in accordance with Hong Kong Financial Reporting Standards ("HKFRSs") which collectively includes all applicable individual Hong Kong Financial Reporting Standards, Hong Kong Accounting Standards ("HKAS") and Interpretations ("Int") issued by the Hong Kong Institute of Certified Public Accountants (the "HKICPA"). The consolidated financial statements also include the applicable disclosure requirements of the Hong Kong Companies Ordinance and the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the "Listing Rules").

The consolidated financial statements for the year ended 31 March 2013 were approved for issue by the board of directors (the "Board") on 25 June 2013.

HKFRS 10 - Consolidated Financial Statements

HKFRS 10 introduces a single control model for consolidation of all investee entities. An investor has control when it has power over the investee (whether or not that power is used in practice), exposure or rights to variable returns from the investee and the ability to use the power over the investee to affect those returns. HKFRS 10 contains extensive guidance on the assessment of control. For example, the standard introduces the concept of "de facto" control where an investor can control an investee while holding less than 50% of the investee's voting rights in circumstances where its voting interest is of sufficiently dominant size relative to the size and dispersion of those of other individual shareholders to give it power over the investee. Potential voting rights are considered in the analysis of control only when these are substantive, i.e. the holder has the practical ability to exercise them. The standard explicitly requires an assessment of whether an investor with decision making rights is acting as principal or agent and also whether other parties with decision making rights are acting as agents of the investor. An agent is engaged to act on behalf of and for the benefit of another party and therefore does not control the investee when it exercises its decision making authority. The accounting requirements in the existing HKAS 27 on other consolidation related matters are carried forward unchanged. HKFRS 10 is applied retrospectively.

HKFRS 11 – Joint Arrangements

Joint arrangements under HKFRS 11 have the same basic characteristics as joint ventures under HKAS 31. Joint arrangements are classified as either joint operations or joint ventures. Where the Group has rights to the assets and obligations for the liabilities of the joint arrangement, it is regarded as a joint operator and will recognise its interests in the assets, liabilities, income and expenses arising from the joint arrangement. Where the Group has rights to the net assets of the joint arrangement as a whole, it is regarded as having an interest in a joint venture and will apply the equity method of accounting. HKFRS 11 does not allow proportionate consolidation. In an arrangement structured through a separate vehicle, all relevant facts and circumstances should be considered to determine whether the parties to the arrangement have rights to the net assets of the arrangement. Previously, the existence of a separate legal entity was the key factor in determining the existence of a jointly controlled entity under HKAS 31. HKFRS 11 is applied retrospectively.

The general objective of the standard is to enable users of financial statements to evaluate the nature and risks of a reporting entity's interests in other entities and the effects of those interests on the reporting entity's financial statements. The directors conclude that the adoption of HKFRS 12 has no material impact on the Group's financial statements, except for additional disclosures for subsidiaries and joint arrangements.

In the course of the Group's reassessment of the accounting for all of its investments in other entities, the Group has determined that it controls one of the property development projects held by its joint venture company under the terms of the designated operating agreement entered into between the Group and its joint venture partner in respect of the project during the preceding period. Accordingly, the Group now recognises the assets, liabilities, income and expenses of the project in its consolidated financial statements. The Group's other interests in the joint venture company continue to be accounted for using the equity method. As the Group obtained control of the project in the preceding period the comparative information for the year ended 31 March 2012 has been restated. No additional consolidated statement of financial position as at 1 April 2011 is presented as the position at that date is not affected.

The improvements made amendments to four standards.

(i) HKAS 1 Presentation of Financial Statements

The amendments clarify that the requirement to present a third statement of financial position when an entity applies an accounting policy retrospectively or makes a retrospective restatement or reclassification of items in its financial statements is limited to circumstances where there is a material effect on the information in that statement of financial position. The date of the opening statement of financial position is the beginning of the preceding period and not, as at present, the beginning of the earliest comparative period. The amendments also clarify that, except for disclosures required by HKAS 1.41-44 and HKAS 8, the related notes to the third statement of financial position are not required to be presented. An entity may present additional voluntary comparative information as long as that information is prepared in accordance with HKFRS. HKFRS 9 – Financial instruments

Under HKFRS 9, financial assets are classified into financial assets measured at fair value or at amortised cost depending on the entity's business model for managing the financial assets and the contractual cash flow characteristics of the financial assets. Fair value gains or losses will be recognised in profit or loss except for those non-trade equity investments, which the entity will have a choice to recognise the gains and losses in other comprehensive income. HKFRS 9 carries forward the recognition, classification and measurement requirements for financial liabilities from HKAS 39, except for financial liabilities that are designated at fair value through profit or loss, where the amount of change in fair value attributable to change in credit risk of that liability is recognised in other comprehensive income unless that would create or enlarge an accounting mismatch. In addition, HKFRS 9 retains the requirements in HKAS 39 for de-recognition of financial assets and financial liabilities.

HKFRS 13 - Fair Value Measurement

HKFRS 13 provides a single source of guidance on how to measure fair value when it is required or permitted by other standards. The standard applies to both financial and non-financial items measured at fair value and introduces a fair value measurement hierarchy. The definitions of the three levels in this measurement hierarchy are generally consistent with HKFRS 7 "Financial Instruments: Disclosures". HKFRS 13 defines fair value as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (i.e. an exit price). The standard removes the requirement to use bid and ask prices for financial assets and liabilities guoted in an active market. Rather the price within the bid-ask spread that is most representative of fair value in the circumstances should be used. It also contains extensive disclosure requirements to allow users of the financial statements to assess the methods and inputs used in measuring fair values and the effects of fair value measurements on the financial statements. HKFRS 13 can be adopted early and is applied prospectively.

The Group is in the process of making an assessment of the potential impact of these pronouncements. Directors so far concluded that the application of these pronouncements will have no material impact on the Group's financial statements.

香港財務報告準則第13號一公平值計量

香港財務報告準則第13號提供有關如何在 其他準則要求或准許時計量公平值之單一 指引來源。該準則適用於按公平值計量之 金融及非金融項目,並引入公平值計量等 級。此計量等級中三個層級之定義一般與 香港財務報告準則第7號「金融工具:披露」 一致。香港財務報告準則第13號將公平值 界定為市場參與者於計量日期進行之有序 交易中出售資產所收取或轉讓負債所支付 之價格(即平倉價)。該準則剔除使用於 交投活躍市場掛牌之金融資產及負債之買 入價及賣出價規定,並採用於該等情況下 最能代表公平值之買賣差價中之價格。該 準則亦載有廣泛之披露規定,使財務報表 使用者可評估計量公平值所採用之方法及 輸入數據,以及公平值計量對財務報表之 影響。香港財務報告準則第13號可提早採 納,並相應應用。

3. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The significant accounting policies adopted in the preparation of the consolidated financial statements are summarised below. These policies have been consistently applied to all the years presented unless otherwise stated. The adoption of new and revised HKFRSs and the impacts on the Group's consolidated financial statements, if any, are disclosed in note 2.

3.1 Basis of preparation

The consolidated financial statements have been prepared under the historical cost basis, except for investment properties which are measured at fair values. The measurement bases are fully described in the accounting policies below.

It should be noted that accounting estimates and assumptions are used in preparation of the consolidated financial statements. Although these estimates are based on management's best knowledge and judgment of current events and actions, actual results may ultimately differ from those estimates. The areas involving a higher degree of judgment or complexity, or areas where assumptions and estimates are significant to the consolidated financial statements, are disclosed in note 4.

3.2 Basis of consolidation and business combination

The consolidated financial statements incorporate the financial statements of the Company and its subsidiaries (note 3.3) made up to 31 March each year.

Inter-company transactions and balances between group companies together with unrealised profits are eliminated in full in preparing the consolidated financial statements. Unrealised losses are also eliminated unless the transaction provides evidence of impairment on the asset transferred, in which case the loss is recognised in profit or loss.

The results of subsidiaries acquired or disposed of during the year are included in the consolidated statement of comprehensive income from the effective dates of acquisition or up to the effective dates of disposal, as appropriate. Where necessary, adjustments are made to the financial statements of subsidiaries to bring their accounting policies in line with those used by other members of the Group.

Acquisition of subsidiaries or businesses is accounted for using the acquisition method. The cost of an acquisition is measured at the aggregate of the acquisition-date fair value of assets transferred, liabilities incurred and equity interests issued by the Group, as the acquirer. The identifiable assets acquired and liabilities assumed are principally measured at acquisition date fair value. The Group's previously held equity interest in the acquiree is re-measured at acquisition-date fair value and the resulting gains or losses are recognised in profit or loss. The Group may elect, on a transaction-by-transaction basis, to measure the non-controlling interest that represent present ownership interests in the subsidiary either at fair value or at the proportionate share of the acquiree's identifiable net assets. All other noncontrolling interests are measured at fair value unless another measurement basis is required by HKFRS. Acquisition-related costs incurred are expensed unless they are incurred in issuing equity instruments in which case the costs are deducted from equity.

集團內公司間之交易及結餘連同未 變現溢利均於編製綜合財務報表時 全數對銷。除非有關交易提供所轉 讓資產減值之證據,否則未變現虧 損亦予以對銷,在此情況下,虧損於 損益中確認。

於年內購入或出售之附屬公司之業 績由收購生效日期起計或直至出售 生效日期止(視情況而定),計入綜 合全面收益表內。於必要時,附屬公 司之財務報表將予調整以使其會計 政策與本集團其他成員公司所使用 者一致。

Any contingent consideration to be transferred by the acquirer is recognised at acquisition date fair value. Subsequent adjustments to consideration are recognised against goodwill only to the extent that they arise from new information obtained within the measurement period (a maximum of 12 months from the acquisition date) about the fair value at the acquisition date. All other subsequent adjustments to contingent consideration classified as an asset or a liability are recognised in profit or loss.

Contingent consideration balances arising from business combinations whose acquisition dates preceded 1 January 2010 (i.e. the date the Group first applied HKFRS 3 (2008)) have been accounted for in accordance with the transition requirements in the standard. Such balances are not adjusted upon first application of the standard. Subsequent revisions to estimates of such consideration are treated as adjustments to the cost of these business combinations and are recognised as part of goodwill.

Changes in the Group's interests in subsidiaries that do not result in a loss of control are accounted for as equity transactions. The carrying amounts of the Group's interest and the non-controlling interest are adjusted to reflect the changes in their relative interests in the subsidiaries. Any difference between the amount by which the non-controlling interest is adjusted and the fair value of the consideration paid or received is recognised directly in equity and attributed to owners of the Company.

When the Group loses control of a subsidiary, the profit or loss on disposal is calculated as the difference between (i) the aggregate of the fair value of the consideration received and the fair value of any retained interest and (ii) the previous carrying amount of the assets (including goodwill), and liabilities of the subsidiary and any non-controlling interest. Amounts previously recognised in other comprehensive income in relation to the subsidiary are accounted for in the same manner as would be required if the relevant assets or liabilities were disposed of.

Subsequent to acquisition, the carrying amount of non-controlling interests that represent present ownership interests in the subsidiary is the amount of those interests at initial recognition plus the non-controlling interest's share of subsequent changes in equity. Total comprehensive income is attributed to non-controlling interests even if this results in the non-controlling interest having a deficit balance.

3.3 Subsidiaries

Subsidiaries are entities controlled by the Group. The Group controls an entity when it is exposed to, or has rights to, variable returns from its involvement with the entity and has the ability to affect those returns through its power over the entity. The financial statements of the subsidiaries are included in the consolidated financial statements from the date that control commences until the date that control ceases.

In the Company's statement of financial position, investments in subsidiaries are stated at cost less impairment loss, if any. The results of subsidiaries are accounted for by the Company on the basis of dividend received and receivable.

3.4 Joint arrangements

Joint arrangements are classified as either a joint operation or joint venture, based on the rights and obligations arising from the contractual arrangements between the parties to the arrangement.

Joint venture

A joint venture is a joint arrangement whereby the parties that have joint control of the arrangement have rights to the net assets of the arrangement.

The Group's interest in a joint venture is stated in the consolidated statement of financial position at the Group's share of net assets under the equity method of accounting, less any impairment losses. Adjustments are made to bring into line any dissimilar accounting policies that may exist. The Group's share of the post acquisition results and reserves of joint ventures is included in the consolidated income statement and consolidated reserves, respectively. Unrealised gains and losses resulting from transactions between the Group and its joint ventures are eliminated to the extent of the Group's investments in the joint ventures, except where unrealised losses provide evidence of an impairment of the asset transferred.

Goodwill arising from the acquisition of joint ventures is included as part of the Group's investments in joint ventures and is not individually tested for impairment.

3.5 Foreign currency translation

The consolidated financial statements are presented in Renminbi ("RMB"), which is also the functional currency of the Company.

In the individual financial statements of the consolidated entities, foreign currency transactions are translated into the functional currency of the individual entity using the exchange rates prevailing at the dates of the transactions. At the reporting date, monetary assets and liabilities denominated in foreign currencies are translated at the foreign exchange rates ruling at that date. Foreign exchange gains and losses resulting from the settlement of such transactions and from the reporting date retranslation of monetary assets and liabilities are recognised in profit or loss.

Non-monetary items carried at fair value that are denominated in foreign currencies are retranslated at the rates prevailing on the date when the fair value was determined and are reported as part of the fair value gain or loss. Non-monetary items that are measured at historical cost in a foreign currency are not retranslated.

In the consolidated financial statements, all individual financial statements of foreign operations, originally presented in a currency different from the Group's presentation currency, have been converted into RMB. Assets and liabilities have been translated into RMB at the closing rates at the reporting date. Income and expenses have been converted into RMB at the exchange rates ruling at the transaction dates, or at the average rates over the reporting period provided that the exchange rates do not fluctuate significantly. Any differences arising from this procedure have been recognised in other comprehensive income and accumulated separately in the translation reserve in equity.

於綜合實體之個別財務報表中,外幣交易使用於交易日通行之匯率換算為個別實體之功能貨幣。於報告日期,以外幣計值之貨幣資產及負債以於該日期之通行外匯匯率與算。因結算該等交易及於報告日期重新換算貨幣資產及負債而產生之匯兑收益及虧損於損益確認。

按公平值列賬且以外幣列值之非貨 幣項目乃按釐定公平值當日通行匯 率重新換算,並呈報為公平值損益 之一部分。以外幣歷史成本計算之 非貨幣項目不予重新換算。

When a foreign operation is disposed of, such exchange differences are reclassified from equity to profit or loss as part of the gain or loss on disposal.

3.6 Revenue recognition

Revenue comprises the fair value of the consideration for the sale of properties, rendering of services and the use by others of the Group's assets yielding interest and dividends, net of rebates and discounts. Provided it is probable that the economic benefits will flow to the Group and the revenue and costs, if applicable, can be measured reliably, revenue is recognised as follows:

Revenue arising from sale of properties held for sale is recognised upon the transfer of the significant risks and rewards of ownership of these properties held for sale to the customers. Revenue is recognised upon the signing of the sale and purchase agreement or the issue of an occupation permit by the relevant government authorities, whichever is the later. Deposits and instalments received from customers prior to the date of revenue recognition are included in current liabilities as receipts in advance.

Interest income is recognised on a time-proportion basis using the effective interest method.

Rental income receivable under operating leases is recognised in equal instalments over the periods covered by the lease terms.

3.7 Property, plant and equipment

Property, plant and equipment are stated at cost less accumulated depreciation and impairment losses. The cost of an asset comprises its purchase price and any directly attributable costs of bringing the asset to the working condition and location for its intended use. Subsequent costs are included in the asset's carrying amount or recognised as a separate asset, as appropriate, only when it is probable that future economic benefits associated with the item will flow to the Group and the cost of the item can be measured reliably. All other costs, such as repairs and maintenance are charged to the consolidated statement of comprehensive income during the period in which they are incurred.

Depreciation is provided to write off the cost of property, plant and equipment over their estimated useful lives, using the straight line method, at the following rates per annum:

Computers and 20.0% other equipment

Motor vehicles 20.0%
Buildings The shorter of the lease terms and 2.5%

The assets' residual values, useful lives and the depreciation method are reviewed, and adjusted if appropriate, at each reporting date.

The gain or loss arising on retirement or disposal is determined as the difference between the sales proceeds and the carrying amount of the asset and is recognised in the consolidated statement of comprehensive income.

3.8 Investment properties

Investment properties are land and/or buildings which are owned or held under a property interest to earn rental income and/or for capital appreciation. These include land held for a currently undetermined future use and property that is being constructed or developed for future use as investment property.

On initial recognition, investment properties are measured at cost, including any directly attributable expenditure. Subsequent to initial recognition, investment properties are stated at fair value, unless it is still in the course of construction or development at the reporting date and its fair value cannot be reliably determined at that time.

Fair value is determined by external professional valuers with sufficient experience with respect to both the location and the nature of the investment properties. The carrying amounts recognised in the consolidated statement of financial position reflect the prevailing market conditions at the reporting date.

Gain or loss arising from either a change in fair value or the sale of investment properties is included in the consolidated statement of comprehensive income for the year in which it arises.

For a transfer from properties held under development to investment properties that is carried at fair value, any difference between fair value of the property at that date and its previous carrying amount is recognised in the consolidated statement of comprehensive income.

投資物業於初步確認時按成本(包括任何應計之直接開支)計量。初步確認後,除非投資物業在報告日期仍然在興建或開發過程中,而當時其公平值不能可靠地確定,否則投資物業按公平值列賬。

公平值由對投資物業地點及性質具足夠經驗之外部專業估值師釐定。 於綜合財務狀況表中確認之賬面值,反映於報告日期之當時市況。

公平值變動或出售投資物業所產生 之收益或虧損於其產生之年度於綜 合全面收益表確認。

Properties under construction or development for future use as an investment property are classified as investment property under construction. If the fair value cannot be reliably determined, the investment property under construction will be measured at cost until such time as fair value can be determined or construction is completed.

When the Group completes the construction or development of a self-constructed investment property, any difference between the fair value of the property at the completion date and its previous carrying amount is recognised in the consolidated statement of comprehensive income.

3.9 Impairment of non-financial assets

Property, plant and equipment and the interests in subsidiaries and a joint venture are subject to impairment testing and are tested for impairment whenever there are indications that the assets' carrying amount may not be recoverable.

An impairment loss is recognised as an expense immediately for the amount by which the asset's carrying amount exceeds its recoverable amount. The recoverable amount is the higher of fair value, reflecting market conditions less cost to sell, and value in use. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessment of time value of money and the risk specific to the asset.

For the purposes of assessing impairment, where an asset does not generate cash inflows largely independent from those from other assets, the recoverable amount is determined for the smallest group of assets that generate cash inflows independently (i.e. a cash generating unit). As a result, some assets are tested individually for impairment and some are tested at cash-generating unit level.

3.9 非金融資產之減值

物業、廠房及設備及於附屬公司及 合營企業之權益需受減值測試,並 於出現資產之賬面值可能無法收回 之跡象時進行減值測試。

減值虧損按資產之賬面值超出其 可收回金額之差額,即時確認為開 支。可收回金額為反映市況之公平 值減銷售成本與使用價值兩者之較 高者。評估使用價值時,估計日後現 金流量採用稅前折現率折現至其現 值,以反映現時市場對金錢時間值 及有關資產特有風險之評估。

An impairment loss is reversed if there has been a favourable change in the estimates used to determine the asset's recoverable amount and only to the extent that the asset's carrying amount does not exceed the carrying amount that would have been determined, net of depreciation, if no impairment loss had been recognised.

3.10 Leases

An arrangement, comprising a transaction or a series of transactions, is or contains a lease if the Group determines that the arrangement conveys a right to use a specific asset or assets for an agreed period of time in return for a payment or a series of payments. Such a determination is made based on an evaluation of the substance of the arrangement and is regardless of whether the arrangement takes the legal form of a lease.

Leases where substantially all the risks and rewards of ownership of assets remain within the lessor are accounted for as operating lease. Where the Group has the use of assets held under operating leases, payments made under the leases are charged to the consolidated statement of comprehensive income on a straight line basis over the lease terms except where an alternative basis is more representative of the pattern of benefits to be derived from the leased assets. Lease incentives received are recognised in the consolidated statement of comprehensive income as an integral part of the aggregate net lease payments made. Contingent rental are charged to the consolidated statement of comprehensive income in the accounting period in which they are incurred.

Leasehold interests in land are up-front payments to acquire the land use right. The payments are stated at cost less accumulated amortisation and any impairment losses. Amortisation is calculated on the straight-line basis over the lease term.

土地租賃權益為收購土地使用權之 前期付款。有關付款按成本減累計 攤銷及任何減值虧損列賬。攤銷乃 於租約年期內按直線法計算。

For leasehold interest in land included in properties held under development and properties held for sale, the amortisation of prepaid land lease is capitalised as part of the building costs during the development period but charged to the consolidated statement of comprehensive income for completed properties. Other amortisation of prepaid land lease is expensed.

Properties leased out under operating leases are included in the consolidated statement of financial position as investment properties. The recognition of rental income is set out in note 3.6.

3.11 Financial assets

The Group's accounting policies for financial assets are set out below.

Financial assets are classified into loans and receivables.

Management determines the classification of its financial assets at initial recognition depending on the purpose for which the financial assets were acquired and where allowed and appropriate, reevaluates this designation at every reporting date.

All financial assets are recognised when, and only when, the Group becomes a party to the contractual provisions of the instrument. All regular way purchases and sales of financial assets are recognised on trade date. When financial assets are recognised initially, they are measured at fair value, plus, in the case of investments not at fair value through profit or loss, directly attributable transaction costs.

Derecognition of financial assets occurs when the rights to receive cash flows from the investments expire or are transferred and substantially all of the risks and rewards of ownership have been transferred.

At each reporting date, financial assets are reviewed to assess whether there is objective evidence of impairment. If any such evidence exists, impairment loss is determined and recognised based on the classification of the financial asset.

Loans and receivables

Loans and receivables are non-derivative financial assets with fixed or determinable payments that are not quoted in an active market. Loans and receivables are subsequently measured at amortised cost using the effective interest method, less any impairment losses. Amortised cost is calculated taking into account any discount or premium on acquisition and includes fees that are an integral part of the effective interest rate and transaction cost.

At each reporting date, financial assets other than at fair value through profit or loss are reviewed to determine whether there is any objective evidence of impairment.

- significant changes in the technological, market, economic or legal environment that have an adverse effect on the debtor; and

Loss events in respect of a group of financial assets include observable data indicating that there is a measurable decrease in the estimated future cash flows from the group of financial assets. Such observable data includes but not limited to adverse changes in the payment status of debtors in the group and, national or local economic conditions that correlate with defaults on the assets in the group.

If there is objective evidence that an impairment loss on loans and receivables carried at amortised cost has been incurred, the amount of the loss is measured as the difference between the asset's carrying amount and the present value of estimated future cash flows (excluding future credit losses that have not been incurred) discounted at the financial asset's original effective interest rate (i.e. the effective interest rate computed at initial recognition). The amount of the loss is recognised in the profit or loss of the period in which the impairment occurs. In relation to trade and notes receivables, a provision for impairment is made when there is objective evidence (such as the probability of insolvency or significant financial difficulties of the debtor) that the Group will not be able to collect all of the amounts due under the original terms of the invoice. Except for trade and notes receivables, the carrying amount of loans and receivables is directly reduced by any identified amount of impairment. The carrying amount of financial asset is reduced through the use of an allowance account. When any part of financial asset is determined as uncollectible, it is written off against the allowance account for the relevant financial asset.

If, in subsequent period, the amount of the impairment loss decreases and the decrease can be related objectively to an event occurring after the impairment was recognised, the previously recognised impairment loss is reversed to the extent that it does not result in a carrying amount of the financial asset exceeding what the amortised cost would have been had the impairment not been recognised at the date the impairment is reversed. The amount of the reversal is recognised in profit or loss during the period in which the reversal occurs.

Properties held under development which are held for future sale are included in current assets. and comprise land held under operating lease (note 3.10) and aggregate cost of development, materials and supplies, wages, and other expenses ("development costs"). Properties held under development are stated at the lower of cost and net realisable value. Other expenses included (a) those costs that are incurred in bringing the properties held under development to their present location and condition; and (b) a systematic allocation of fixed overheads that are incurred on development of properties. Fixed overheads are indirect costs which remain relatively constant regardless of the size or volume of the development.

On completion, the properties are transferred to properties held for sale. Cost is calculated using the weighted average method.

Net realisable value is the estimated selling price in the ordinary course of business less the estimated costs of completion and applicable selling expenses.

Properties under development are classified as current assets unless the construction period of the relevant property development project is expected to complete beyond normal operating cycle.

3.13 Properties held for sale

In case of completed properties developed by the Group, cost is determined by apportionment of the total development costs for that development project, attributable to the unsold properties. The cost of completed properties held for sale comprises all costs of purchase, cost of conversion and other costs incurred in bringing the inventories to their present location and condition.

Properties held for sale are stated at the lower of cost and net realisable value. Net realisable value is the estimated selling price in the ordinary course of business less estimated selling expenses.

3.14 Accounting for income taxes

Income tax comprises current and deferred tax.

Current income tax assets and/or liabilities comprise those obligations to, or claims from, fiscal authorities relating to the current or prior reporting period, that are unpaid at the reporting date. They are calculated according to the tax rates and tax laws applicable to the fiscal periods to which they relate, based on the taxable profit for the year. All changes to current tax assets or liabilities are recognised as a component of tax expense in profit or loss.

Deferred tax is calculated using the liability method on temporary differences at the reporting date between the carrying amounts of assets and liabilities in the financial statements and their respective tax bases. Deferred tax liabilities are generally recognised for all taxable temporary differences. Deferred tax assets are recognised for all deductible temporary differences, tax losses available to be carried forward as well as other unused tax credits, to the extent that it is probable that taxable profit, including existing taxable temporary differences, will be available against which the deductible temporary differences, unused tax losses and unused tax credits can be utilised.

Deferred tax assets and liabilities are not recognised if the temporary difference arises from initial recognition (other than in a business combination) of assets and liabilities in a transaction that affects neither taxable nor accounting profit or loss.

Deferred tax liabilities are recognised for taxable temporary differences arising on investments in subsidiaries and associates, except where the Group is able to control the reversal of the temporary differences and it is probable that the temporary differences will not reverse in the foreseeable future

Deferred tax is calculated, without discounting, at tax rates that are expected to apply in the period the liability is settled or the asset realised, provided they are enacted or substantively enacted at the reporting date.

An exception to the general requirement on determining the appropriate tax rate used in measuring deferred tax amount is when an investment property is carried at fair value under HKAS 40 "Investment Property". Unless the presumption is rebutted, the deferred tax amounts on these investment properties are measured using the tax rates that would apply on sale of these investment properties at their carrying amounts at the reporting date. The presumption is rebutted when the investment property is depreciable and is held within a business model whose objective is to consume substantially all the economic benefits embodied in the property over time, rather than through sale.

Changes in deferred tax assets or liabilities are recognised in profit or loss, or in other comprehensive income or directly in equity if they relate to items that are charged or credited to other comprehensive income or directly to equity.

Current tax assets and current tax liabilities are presented in net if, and only if,

- (a) the Group has the legally enforceable right to set off the recognised amounts; and
- (b) intends either to settle on a net basis, or to realise the asset and settle the liability simultaneously.

 - (i) the same taxable entity; or
 - (ii) different taxable entities which intend either to settle current tax liabilities and assets on a net basis, or to realise the assets and settle the liabilities simultaneously, in each future period in which significant amounts of deferred tax liabilities or assets are expected to be settled or recovered.

3.15 Cash and cash equivalents

Cash and cash equivalents include cash at bank and in hand, demand deposits with banks and short term highly liquid investments with original maturities of three months or less that are readily convertible into known amounts of cash and which are subject to an insignificant risk of changes in value. For the presentation of purpose of the consolidated statement of cash flows, cash and cash equivalents include bank overdrafts which are repayable on demand and form an integral part of the Group's cash management.

Ordinary shares are classified as equity. Share capital is determined using the nominal value of shares that have been issued.

Share premium includes any premiums received on the issuance of shares over the par value. Any transaction costs associated with the issuance of shares are deducted from share premium (net of any related income tax benefit) to the extent they are incremental costs directly attributable to the equity transaction.

3.17 Retirement benefit costs and short-term employee benefits

Retirement benefit costs

The Group operates a defined contribution scheme ("MPF Scheme") under the Mandatory Provident Fund Scheme Ordinance which is available to its employees in Hong Kong. Contributions to the MPF Scheme by the Group and employees are made based on a percentage of employees' basic salaries and are charged to the consolidated statement of comprehensive income as they become payable in accordance with the rules of the MPF Scheme.

Pursuant to the relevant regulations in the People's Republic of China (the "PRC"), the Group has participated in a local municipal government retirement benefit scheme (the "Scheme"), whereby the Group is required to contribute a certain percentage of basic salaries of its employees to the Scheme to fund their retirement benefits. The local municipal government undertakes to assume the retirement benefits obligations of all existing and future retired employees in the PRC. The only obligation of the Group with respect to the Scheme is to pay the ongoing required contributions under the Scheme mentioned above. The Group's contributions to the Scheme are expensed as incurred.

Short-term employee benefits

Employee entitlements to annual leave are recognised when they accrue to employees. A provision is made for the estimated liability for annual leave as a result of services rendered by employees up to the reporting date.

Non-accumulating compensated absences such as sick leave and maternity leave are not recognised until the time of leave.

3.18 Financial liabilities

The Group's financial liabilities include account and other payables and bank and other loans.

Financial liabilities are recognised when the Group becomes a party to the contractual provisions of the instrument. All interest related charges are recognised in accordance with the Group's policy on borrowing costs (note 3.21).

A financial liability is derecognised when the obligation under the liability is discharged or cancelled or expires.

Where an existing financial liability is replaced by another from the same lender on substantially different terms, or the terms of an existing liability are substantially modified, such an exchange or modification is treated as a derecognition of the original liability and the recognition of a new liability, and the difference in respective carrying amount is recognised in the consolidated statement of comprehensive income.

Bank and other loans

Bank and other loans are recognised initially at fair value, net of transaction costs incurred. Bank and other loans are subsequently stated at amortised cost; any difference between the proceeds (net of transaction costs) and the redemption value is recognised in the consolidated statement of comprehensive income over the period of the loans using the effective interest method.

Bank and other loans are classified as current liabilities unless the Group has an unconditional right to defer settlement of the liability for at least 12 months after the reporting date.

Accounts payable and other payables

Accounts payable and other payables are recognised initially at their fair value and subsequently measured at amortised cost, using the effective interest method.

3.19 Provisions and contingent liabilities

Provisions are recognised when the Group has a present obligation (legal or constructive) as a result of a past event, and it is probable that an outflow of economic benefits will be required to settle the obligation and a reliable estimate of the amount of the obligation can be made. Where the time value of money is material, provisions are stated at the present value of the expenditure expected to settle the obligation.

All provisions are reviewed at each reporting date and adjusted to reflect the current best estimate.

Where it is not probable that an outflow of economic benefits will be required, or the amount cannot be estimated reliably, the obligation is disclosed as a contingent liability, unless the probability of outflow of economic benefits is remote. Possible obligations, whose existence will only be confirmed by the occurrence or non-occurrence of one or more future uncertain events not wholly within the control of the Group, are also disclosed as contingent liabilities unless the probability of outflow of economic benefits is remote.

Contingent liabilities are recognised in the course of the allocation of purchase price to the assets and liabilities acquired in a business combination. They are initially measured at fair value at the date of acquisition and subsequently measured at the higher of the amount that would be recognised in a comparable provision as described above and the amount initially recognised less any accumulated amortisation, if appropriate.

3.20 Financial guarantees issued

A financial guarantee contract is a contract that requires the issuer (or guarantor) to make specified payments to reimburse the holder for a loss it incurs because a specified debtor fails to make payment when due in accordance with the terms of a debt instrument.

Where no such consideration is received or receivable, an immediate expense is recognised in profit or loss on initial recognition of any deferred income.

The amount of the guarantee initially recognised as deferred income is amortised in profit or loss over the term of the guarantee as income from financial guarantees issued.

In addition, provisions are recognised if and when it becomes probable that the holder of the guarantee will call upon the Group under the guarantee and the amount of that claim on the Group is expected to exceed the current carrying amount i.e. the amount initially recognised less accumulated amortisation, where appropriate.

3.21 Borrowing costs

Borrowing costs incurred for the acquisition, construction or production of any qualifying asset are capitalised during the period of time that is required to complete and prepare the asset for its intended use. A qualifying asset is an asset which necessarily takes a substantial period of time to get ready for its intended use or sale. Other finance costs are expensed.

Capitalisation of borrowing costs ceases when substantially all the activities necessary to prepare the qualifying asset for its intended use or sale are completed.

3.22 Dividends

Final dividends proposed by the directors are classified as a separate allocation of retained profits within equity, until they have been approved by the shareholders in a general meeting. When these dividends are approved and declared, they are recognised as a liability.

3.23 Related parties

- (a) A person or a close member of that person's family is related to the Group if that person:
 - (i) has control or joint control over the Group;
 - (ii) has significant influence over the Group; or
 - (iii) is a member of key management personnel of the Group or the Company's parent.

Individually material operating segments are not aggregated for financial reporting purposes unless the segments have similar economic characteristics and are similar in respect of the nature of products and services, the nature of production processes, the type or class of customers, the methods used to distribute the products or provide the services, and the nature of the regulatory environment. Operating segments which are not individually material may be aggregated if they share a majority of these criteria.

Estimates and judgements are continually evaluated and are based on historical experience and other factors, including expectations of future events that are believed to be reasonable under the circumstances.

4.1 Critical accounting estimates and assumptions

The Group makes estimates and assumptions concerning the future. The resulting accounting estimates will, by definition, seldom equal to the related actual results. The estimates and assumptions that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year are discussed below:

Fair value of investment properties and properties held under development upon transfer to investment properties

The investment properties and properties held under development upon transfer to investment properties of the Group were stated at fair value in accordance with the accounting policy. The fair value of the investment properties is determined by a firm of independently qualified professional surveyors and the fair value of investment properties as at the reporting dates and properties held under development upon transfer to investment properties are set out in notes 15 and 18 respectively. Such valuation was based on certain assumptions, which are subject to uncertainty and might materially differ from the actual results.

Impairment of accounts and other receivables

The Group's management assesses the collectability of accounts and other receivables. This estimate is based on the credit history of its customers or counterparties and the current market condition. Management reassesses the impairment loss at the reporting date.

Net realisable value of properties held for sale and properties held under development

Management determines the net realisable value of properties held for sale and properties under development by using prevailing market data such as most recent sale transactions and market survey reports available from independent property valuers, and internal estimates of costs based on quotes by suppliers.

These estimates require judgment as to the anticipated sale prices by reference to recent sales transactions in nearby locations, rate of new property sales, marketing costs (including price discounts required to stimulate sales) and the expected costs of completion of properties, the legal and regulatory framework and general market conditions.

4.2 Critical judgements in applying the entity's accounting policies

Revenue recognition

The Group has recognised revenue from sale of properties held for sale during the year as disclosed in note 6 to the financial statements. The assessment of when an entity has transferred the significant risks and rewards of ownership to buyer requires examination of the circumstances of the transaction. In most cases, the transfer of risks and rewards of ownership coincides with the transfer of the legal title or the passing of possession to the buyer or a completion certificate is issued by the relevant government authorities. The Group believes that its recognition basis of sales as set out in note 3.6 is appropriate and is the current practice in the PRC.

Estimates of current tax and deferred tax

The Group is subject to taxation in various jurisdictions. Significant judgement is required in determining the amount of the provision of taxation and the timing of payment of the related taxation. Where the final tax outcome is different from the amounts that were initially recorded, such differences will impact the income tax and deferred tax provisions in periods in which such determination are made.

The Group is subject to Land Appreciation Tax ("LAT") in the PRC. However, the implementation and settlement of this tax varies among various tax jurisdictions in cities of the PRC, and the Group has not finalised its LAT calculation and payments with any local tax authorities in the PRC. Accordingly, significant judgement is required in determining the amount of the land appreciation and its related LAT. The Group recognised LAT based on management's best estimates according to the understanding of the tax rules.

5. SEGMENT INFORMATION

For the years presented, executive directors have determined that the Group has only one single business component/reportable segment as the Group is only engaged in the business of sale and lease of properties which is the basis to allocate resources and assess performance.

The geographical location of the specified non-current assets is based on the physical location of the asset, in the case of property, plant and equipment, the location of the operation. In the opinion of the directors of the Company, the majority of the Group's operation and centre of management are sourced from its subsidiaries in Jiangxi Province, the PRC, which considered that the operation base of the Group is domiciled in the PRC, as one geographical location and therefore, no analysis of geographical information is presented.

The total revenue from external customers is mainly sourced from the PRC. The total revenue is disclosed in note 6.

33. FINANCIAL RISK MANAGEMENT OBJECTIVES AND POLICIES

The Group's activities expose the Group to a variety of financial risks which comprise market risk (including foreign currency risk and interest rate risk), credit risk and liquidity risk. The Group's overall risk management focuses on the unpredictability of financial markets and seeks to minimise potential adverse effects on the Group's financial performance. The Group currently does not have any written risk management policies and guidelines. However, the board of directors meets periodically and cooperates closely with key management to analyse and formulate strategies to manage and monitor financial risks.

The Group is not engaged in trading of financial assets for speculative purposes. The most significant financial risks to which the Group is exposed to be described below.

(a) Interest rate risk

Interest rate risk relates to the risk that the fair value or cash flows of a financial instrument will fluctuate because of changes in market interest rate. The Group's income and operating cash flows are substantially independent of changes in market interest rates. The Group's interest rate risk mainly arises from deposits at banks, other receivables and bank and other loans which bore interests at fixed and floating interest rates. Bank and other loans arranged at variable rates and fixed rates expose the Group to cash flow interest rate risk and fair value interest rate risk respectively. The interest rate and repayment terms of the borrowing outstanding at the end of the reporting period are disclosed in note 25.

(a) Interest rate risk (continued)

The Group's bank balances also expose the Group to cash flow interest rate risk due to the fluctuation of the prevailing market interest rate on the bank balances. The directors consider the Group's exposure of the bank deposits is not significant as interest-bearing deposits are within short maturity periods in general.

The Group currently does not have an interest rate hedging policy. However, management monitors interest rate exposure and will consider hedging significant interest rate exposure should the need arise.

(b) Credit risk

Credit risk refers to the risk that the counterparty to a financial instrument would fail to discharge its obligation under the terms of the financial instrument and cause a financial loss to the Group. The Group's exposure to credit risk mainly arises from granting credit to customers in the ordinary course of its operations. The Group is also exposed to credit risk arising from the provision of financial guarantees and the amounts of which are disclosed in note 31.

The Group continuously monitors defaults of customers and other counterparties, identified either individually or by group, and incorporates this information into its credit risk controls. The Group's policy is to deal only with creditworthy counterparties.

本集團繼續監察個別或組別確認之 客戶及其他對手方之拖欠情況,並 將有關資料載入其信貸風險控制。 本集團之政策為僅與信貸記錄良好 之對手方交易。

(b) Credit risk (continued)

The Group's management considers that all the above financial assets that are not impaired for at the end of reporting period are of good credit quality, including those that are past due.

None of the Group's financial assets are secured by collateral or other credit enhancements.

In respect of account and other receivables, the Group is not exposed to any significant credit risk exposure to any single counterparty or any group of counterparties having similar characteristics. The credit risk for cash at bank is considered negligible, since the counterparties are reputable banks with high quality external credit ratings.

(c) Foreign currency risk

Most of the Group's transactions are carried out in RMB which is the functional currency of the Company and most of the operating subsidiaries. Exposures to currency exchange rates arise from certain of the Group's cash and bank balances which are denominated in HK\$. The Group does not use derivative financial instruments to hedge its foreign currency risk. The Group reviews its foreign currency exposures regularly and considers no significant exposure on its foreign exchange risk.

(c) 外幣風險

本集團大部份交易以人民幣進行, 而人民幣乃本公司及大多數營運附 屬公司之功能貨幣。貨幣匯率風險 來自本集團以港元列值之若干現金 及銀行結餘。本集團並無使用衍生 金融工具以對沖其外幣風險。本集 團定期檢討其外幣風險,並認為其 外匯風險並不重大。

(d) Liquidity risk

Liquidity risk relates to the risk that the Group will not be able to meet its obligations associated with its financial liabilities that are settled by delivering cash or another financial asset. The Group is exposed to liquidity risk in respect of settlement of financial liabilities, including trade and other payables and bank and other loans, and its financial obligations, and also in respect of its cash flow management.

The cash management of all operating entities is centralised, including the raising of funds to cover expected cash demands. The Group's policy is to regularly monitor current and expected liquidity requirements to ensure that it maintains sufficient reserves of cash and adequate committed lines of funding from major financial institutions to meet its liquidity requirements in the short and longer terms.

The table below analyses the Group's financial liabilities based on the remaining contractual maturity date. The amounts disclosed in the table are the contractual undiscounted cash flows.

The management has built an appropriate liquidity risk management framework for the management of the Group's short, medium and long-term funding and liquidity management requirements. The Group manages liquidity risk by maintaining adequate reserves, banking facilities and reserve banking facilities, and by continuously monitoring forecast and actual cash flows and matching the maturity profiles of financial assets and liabilities.

(e) Fair value

34. EVENTS AFTER THE END OF REPORTING PERIOD

On 2 April 2013, the Group's indirect wholly-owned subsidiary, Sino Harbour, entered into a facility agreement (the "Facility Agreement") with a bank relating to secured term loan facilities (the "Facilities") of an aggregate amount of HK\$315 million for a term of up to 3 years from the date of drawdown, 24 April 2013. The Group obtained the Facilities to finance a land acquisition as result of the Group and the Bureau of Land and Resources of Hangzhou having entered into a land grant contract dated 28 March 2013 for the acquisition of the land use rights of the land in Hangzhou, the PRC, at a consideration of RMB506 million, of which approximately RMB253 million shall be due on 27 April 2013.

35. CAPITAL MANAGEMENT

The Group's objectives when managing capital are:

- To safeguard the Group's ability to continue as a going concern, so that it continues to provide returns and benefits for stakeholders;
- (ii) To support the Group's stability and growth; and
- (iii) To provide capital for the purpose of strengthening the Group's risk management capability.

The Group actively and regularly reviews and manages its capital structure to ensure optimal capital structure and shareholder returns, taking into consideration the future capital requirements of the Group and capital efficiency, prevailing and projected profitability, projected operating cash flows, projected capital expenditures and projected strategic investment opportunities. The Group currently does not adopt any formal dividend policy.
