On 7 October 2015, the Company entered into a placing agreement with RHK OSK Securities Hong Kong Limited (the “Placing Agent” and the “Placing Agreement”, respectively), pursuant to which the Company agreed to place, through the Placing Agent, a maximum of 32,000,000 new ordinary share of the Company (the “Placing Shares”) to not less than six places at a price of HK\$1.56 per placing share, subject to the fulfilment of the conditions precedent set out in the Placing Agreement. 32,000,000 Placing Shares were allotted and issued by the Company on 19 October 2015 pursuant to the Placing Agreement.
